Governor Proposes Extension of Home Buyer Tax Credit

Jobs and Economic Growth

The Governor made it clear that his number one priority in 2010 is fostering a business-friendly economy and creating jobs. In his speech, he outlined measures he will present to the legislature to achieve that priority including:



- The *California Jobs Initiative*, a program to pump jobs into California by creating or retaining up to 100,000 jobs and providing training to 140,000 individuals to enable them to retain their current positions or compete for higher paying jobs.
- A proposal to extend and expand the \$10,000 homebuyer tax credit to include the purchase of existing homes in addition to new residences for first-time homebuyers.
- A proposal to eliminate frivolous lawsuits that punish California's small businesses.

Beware of Making Risky Referrals

The California Department of Consumer Affairs (DCA) licenses and regulates more than 250 professions.

REALTORS® are often asked by clients to make referrals to housing related vendors. Selling products or services without a license in one of the professions regulated by DCA is illegal. Such professions include but are not limited to, structural pest control companies, contactors, architects and electricians.



If you refer a homeowner to an unlicensed business or practitioner and the client is harmed physically or financially, your reputation can be harmed as well. Be sure to tell your clients - Don't take chances. Inquire BEFORE you hire! Check for a valid, good-standing license before you do business with anyone. Checking a license is quick and easy, go to www.inquirebeforeyouhire.ca.gov.
