C.A.R. Housing Affordability Fund Launches Mortgage Protection Program April 2

Through the C.A.R. H.A.F.'s Mortgage Protection Program, first-time home buyers who lose their jobs due to layoffs may be eligible to receive up to \$1,500 per month for up to six months to help make their mortgage payments. A Qualified co-buyer can also participate in this program, for a reduced monthly benefit of \$750 per month for up to six months in the event of a job loss. Program benefits also include coverage for accidental disability and a \$10,000 death benefit. C.A.R.'s Housing Affordability Fund is dedicating \$1 million toward its Mortgage Protection Program, and estimates that up to 3,000 families will benefit from the program this year.
