meeting the requirements of the California Department of Real Estate to be at the Open House in your place. If neither you nor your representative is present and you have not notified the Association you will be fined \$100.

Please note:

If someone other than the listing agent is present, it must be noted in the tour "REMARKS" field.

DRE Requirement: A non-licensee can "sit" at an open house, pass out sales and promotional literature, and/or direct a potential client to a licensee for further discussions. However, a real estate license is required to discuss the terms of a real property transaction and/or the specific housing needs of a potential client.
